COALITIONS ARE SUPPLIED WITH THE RESOURCES TO PROVIDE POISON PREVENTION PROGRAMS AND EDUCATION IN THEIR COMMUNITIES THROUGH PROGRAM-TO-GO KITS AS WELL AS BROCHURES AND HANDOUTS. SAFE KIDS COALITIONS ALSO PARTICIPATE AND HOST OPERATION PILL DROPS, WHICH ARE MEDICATION TAKE-BACK EVENTS WHERE THE PUBLIC CAN DROP OFF PRESCRIPTIONS OR OVER-THE-COUNTER PRODUCTS THAT ARE UNUSED OR EXPIRED.

IN 2015, SAFE KIDS COALITIONS CONDUCTED 103 HOME SAFETY PROGRAMS THAT EDUCATED 109,690 CHILDREN, CAREGIVERS AND PROFESSIONALS. WE DISTRIBUTED 1,573 HOME SAFETY DEVICES AND 30,198 HOME SAFETY EDUCATIONAL MATERIALS.

(3) BIKE SAFETY

MORE CHILDREN 5 TO 14 YEARS OF AGE ARE SEEN IN EMERGENCY DEPARTMENTS FOR INJURIES RELATED TO BIKING THAN ANY OTHER SPORT. THE STATE OF GEORGIA REQUIRES CHILDREN 16 YEARS OF AGE AND YOUNGER TO WEAR A HELMET WHILE RIDING A BICYCLE. IN 2009, GEORGIA PASSED A LAW THAT ALLOWS CHILDREN 12 YEARS OF AGE AND YOUNGER TO BIKE ON SIDEWALKS. THE LAW STATES THAT NO ONE ELSE IS PERMITTED TO OPERATE VEHICLES ON SIDEWALKS IN AN EFFORT TO PREVENT UNSAFE RIDING CONDITIONS. BECAUSE OF THIS, MANY SAFE KIDS COALITIONS HOST BIKE RODEOS FEATURING BIKE INSPECTIONS, HELMET FITTINGS, AND SAFETY TIPS FOR CHILDREN, CAREGIVERS, AND PROFESSIONALS. IN 2015, SAFE KIDS COALITIONS HELD 49 BIKE SAFETY EVENTS AND SPEND 162 HOURS IN EDUCATING 4,265 CHILDREN, CAREGIVERS, AND PROFESSIONALS. 2,876 HELMETS AND 6,563 BIKE SAFETY EDUCATIONAL MATERIALS WERE ALSO DISTRIBUTED BY SAFE KIDS COALITIONS.

UNINTENTIONAL PEDESTRIAN INJURIES ARE THE 5TH LEADING CAUSE OF INJURY-RELATED DEATH FOR CHILDREN AGES 5 TO 19 YEARS OF AGE. SAFE KIDS TEACHES SAFE BEHAVIORS TO MOTORISTS AND CHILD PEDESTRIANS TO CREATE SAFER, MORE WALKABLE COMMUNITIES. SAFE KIDS COALITIONS WORK WITH COMMUNITY LEADERS, PARTNERS, AND THE MEDIA TO SPREAD AWARENESS ABOUT THE IMPORTANCE OF PEDESTRIAN SAFETY. CHILDREN, CAREGIVERS, AND PROFESSIONALS ARE REACHED THROUGH THE INITIATIVES LIKE, INTERNATIONAL WALK TO SCHOOL DAY, HALLOWEEN SAFETY ACTIVITIES, ENVIRONMENTAL TASK FORCES AND SCHOOL SAFETY COMMITTEES.
