IN 2016, OUR COALITIONS CHECKED 6,214 CAR SEATS AND DISTRIBUTED 3,067 SEATS. IN ADDITION, 105,289 CHILDREN, CAREGIVERS, AND PROFESSIONALS HAVE SOME FORM OF CAR SEAT SAFETY EDUCATION. CAR CRASHES KILL MORE YOUNG PEOPLE THAN ANY OTHER INJURY AREA ACCOUNTING FOR NEARLY HALF OF ALL AMERICAN TEEN DEATHS EACH YEAR. IN 2015, NATIONWIDE A TOTAL OF 2,300 TEENS HAD LOST THEIR LIVES IN CAR CRASHES. THIS IS SIX TEENS A DAY TOO MANY. RECOGNIZING THE NEED TO PREVENT THESE INJURIES AND DEATHS FROM OCCURRING, SAFE KIDS GEORGIA WAS ASKED TO COLLABORATE IN A STATEWIDE TEEN DRIVER SAFETY INITIATIVE; "TEENS IN THE DRIVER SEAT". A NATIONALLY RECOGNIZED CURRICULUM ORIGINATING FROM TEXAS A&M, AND FUNDED BY THE GEORGIA DEPARTMENT OF TRANSPORTATION. THE ROLE OF SKG WAS TO ASSIST WITH PROGRAM DEVELOPMENT, IMPLEMENTATION AND EXECUTION WITHIN SCHOOLS THROUGHOUT GEORGIA. THE PARTNERSHIP BEGAN LATE IN 2016 AND IS TO CONTINUE THROUGH 2019, CULMINATING IN THE PARTICIPATION OF 80+ MIDDLE AND HIGH SCHOOLS. DATA ANALYSIS WILL BE USED TO MEASURE OUTCOMES THROUGHOUT THE PROGRAM FOR BOTH EFFICACY AND EFFECTIVENESS THROUGHOUT THE YEAR.

THE GOAL IS TO ADOPT BEST PRACTICES THAT WILL HELP MINIMIZE THE ABOVE WITH THE HOPE OF REDUCING TEEN DRIVER DEATHS.

"TEENS IN THE DRIVER SEAT" IS A CURRICULUM THAT ENCOURAGES, EDUCATES AND EMPOWERS TEENAGERS ON A PEER TO PEER BASIS AS TEENAGERS THAT WISH TO BECOME INVOLVED AS TEEN DRIVER SAFETY ADVOCATES. A SCHOOL REPRESENTATIVE EITHER VOLUNTEERS OR IS ASSIGNED TO LEAD THE EFFORTS ALONG WITH A TEACHER, COUNSELOR OR SCHOOL REPRESENTATIVE THAT ACTS AS A GUIDE ONLY. THE CONTRIBUTORS SELECT WAYS IN WHICH TO PARTICIPATE IN THE SCHOOL ACTIVITIES OF THEIR CHOICE. THIS WOULD ALLOW FOR MORE STUDENT INTERACTION, A GREATER COMMITMENT. THE STUDENTS THEN ENGAGE OTHER VOLUNTEERS TO HELP CREATE MESSAGING THAT COULD INCLUDE POSTERS AND FLYERS ON "HOW TO STAY SAFE". THEY ARE ALSO RESPONSIBLE FOR EDUCATIONAL MATERIAL AND DISSEMINATION, AND SHOULD THEY DESIRE TO DO SO, CAN PRODUCE THEIR OWN PUBLIC SERVICE ANNOUNCEMENTS. SOME OTHER IDEAS THAT WERE GENERATED LAST YEAR INCLUDED HOST SPEAKERS TO SHARE THEIR LIFE STORIES AT A ASSEMBLY WITH PLEDGE FORMS AVAILABLE FOR THE STUDENTS TO SIGN. THE DESIRED OUTCOME IS TO HAVE STUDENTS INITIATING SERIOUS DISCUSSIONS AROUND RISK AND PROVIDING REAL SOLUTIONS. AWARDS ARE GIVEN FOR EXCELLENCE AND OUTSTANDING PARTICIPATION. IN 2016, THREE SCHOOLS WITH THE MOST TEEN SAFETY PREVENTION ACTIVITIES WERE SELECTED TO RECEIVE A MONETARY AWARD OF \$1,500. IN ADDITION, TEENS THAT SHOWED EXTRAORDINARY INGENUITY WITH THEIR PROJECTS RECEIVED SCHOLARSHIPS AND WERE CHOSEN FOR THE NATIONAL TEEN SAFETY ADVISORY BOARD. IN 2016, SAFE

(3) HOME SAFETY

EACH YEAR, IN THE UNITED STATES 2,200 CHILDREN DIE FROM AN INJURY WITHIN A HOME. ACCORDING TO THE CDC, PEDIATRIC UNINTENTIONAL FALLS WERE AMONG THE LEADING CAUSE OF PEDIATRIC NONFATAL INJURY NATIONWIDE. THE MOST RECENT DATA FROM THE ONLINE ANALYTICAL STATISTICAL INFORMATION SYSTEM (OASIS) SHOWED THAT IN 2015, CHILDREN 19 AND UNDER IN OUR TARGETED COUNTIES ACCOUNTED FOR 59,600 EMERGENCY ROOM VISITS RESULTING FROM FALLS, WITH A RATE OF 2,140.9 PER 100,000 POPULATION. OF THESE, 20,675 VISITS WERE MADE BY CHILDREN 0 TO 4 YEARS OF AGE, AND 15,691 VISITS WERE MADE BY CHILDREN 5 TO 9 YEARS OF AGE. THIS TRANSLATES TO A RATE OF 3132.4 AND 2225.3 PER 100,000 POPULATION. THE DATA SHOWS THAT THERE IS A DISPROPORTIONATELY HIGH FALLS RATE AMONG CHILDREN BIRTH TO 9 COMPRISING 61 % OF THE FALL RELATED EMERGENCY ROOM VISITS.

IN 2015, THERE WERE 14 DEATHS IN BIRTH TO 19 YEARS OF AGE FROM UNINTENTIONAL FALLS IN COUNTIES SERVED BY THE SAFE KIDS COALITIONS. THIS DATA DEMONSTRATES THAT CHILD MORBIDITY, CHILD INJURY, AND THE COST TO THE HEALTHCARE SYSTEM FOR THESE PREVENTABLE FALLS ARE A SIGNIFICANT PUBLIC HEALTH CONCERN. RISKS OF FALLS IN THE HOME ARE RELATED TO FURNITURE, BEDS, AND HIGH SURFACES, WHEREAS FOR CHILDREN AGES 5-9, RISKS RESULT IN FALLS FROM PLAYGROUND EQUIPMENT. THIS KNOWLEDGE IS DELIVERED TO PARENTS AND CAREGIVERS WITH THE INTENTION THAT BEHAVIOR CHANGE WILL FOLLOW AND FAMILIES WILL TAKE PREVENTIVE MEASURES TO REDUCE THE NUMBER OF FALL RELATED INCIDENTS IN THE TARGETED COUNTIES.

HOME SAFETY INJURY PREVENTION AWARENESS, ACTIVITIES AND EDUCATION ARE FOCUSED ON SUFFOCATION, DROWNING, FIRE & BURNS, EMERGENCY PREPAREDNESS, GUN SAFETY, TV TIP-OVERS, SEASONAL HOLIDAY SAFETY, SAFE SLEEP AND TOY SAFETY. IN 2016, SAFE KIDS GEORGIA COALITIONS EXECUTED 484 HOME SAFETY PROGRAMS, DISTRIBUTED 471 HOME SAFETY DEVICES AND PROVIDED EDUCATION TO 54,330 CHILDREN AND THEIR FAMILIES.

(4) WHEELED SPORTS SAFETY

WHEELED SPORTS SAFETY INTERVENTION ENCOMPASSES NOT ONLY BIKE SAFETY, BUT SKATEBOARDS AND SCOOTERS. EACH YEAR, 26,000 CHILDREN ARE TREATED IN EMERGENCY ROOMS FOR TRAUMATIC BRAIN INJURY THAT IS RELATED TO (BIKING ACCIDENTS). STATISTICS SHOW THAT WEARING A PROPERLY FITTED HELMET COULD REDUCE THE RISK OF SEVERE BRAIN INJURIES BY 78%. GEORGIA LAW REQUIRES CHILDREN AGES 16 AND YOUNGER WEAR A HELMET WHILE RIDING A BICYCLE, ALTHOUGH SADLY THIS IS NOT ONLY DIFFICULT TO ENFORCE, IT IS NOT CONSIDERED A PRIORITY.

MORE CHILDREN AGES 5 TO 14 ARE SEEN IN EMERGENCY ROOMS FOR INJURIES RELATED TO BIKING THAN IN ANY OTHER SPORT. HELMETS CAN REDUCE THE RISK OF SEVERE BRAIN INJURIES BY 88% YET ONLY 45 PERCENT OF CHILDREN 14 AND

UNINTENTIONAL PEDESTRIAN INJURIES ARE THE 5TH LEADING CAUSE OF INJURY-RELATED DEATH FOR CHILDREN 5 TO 19 YEARS OF AGE. IN 2015, GEORGIA RANKED 16TH AMONG 50 STATES IN TERMS OF PEDESTRIAN DEATHS. ACCORDING TO A STUDY BY SAFE KIDS WORLDWIDE, 1 IN 5 HIGH-SCHOOLERS AND 1 IN 8 MIDDLE-SCHOOLERS WERE OBSERVED CROSSING THE STREET WHILE DISTRACTED BY PHONES, HEADPHONES AND OTHER MOBILE DEVICES.

FOLLOWING A FEDEX GRANT THAT WAS RECEIVED IN 2014; SAFE KIDS GEORGIA HELPED FACILITATE AN ENVIRONMENTAL MODIFICATION AT INMAN MIDDLE SCHOOL.
