ADDITIONAL VEHICULAR PROGRAMS AND ACTIVITIES INCLUDE, BUT ARE NOT LIMITED TO; COALITIONS COLLABORATE WITH LAW ENFORCEMENT AS THEY EXECUTE ROAD BLOCK EVENTS. SKG CONTINUES TO BE AN INSTRUMENTAL PARTNER IN THE "LOOK AGAIN" AN ANNUAL HYPERTHERMIA AWARENESS AND PREVENTION CAMPAIGN WHICH EDUCATES THE PUBLIC ABOUT THE DANGERS OF LEAVING CHILDREN IN VEHICLES UNATTENDED. APPROXIMATELY, TWENTY OF SAFE KIDS GEORGIA COALITIONS FOCUSED ON HOME SAFETY INITIATIVES THAT DISCLOSED SIMPLE STEPS FAMILIES CAN TAKE TO PREVENT UNINTENTIONAL INJURIES IN AND AROUND THE HOME.

COALITIONS HELD A TOTAL OF 523 EVENTS IN WHICH 69,879 CHILDREN, CAREGIVERS, AND PROFESSIONALS WERE EDUCATED. AS PART OF THE HOME SAFETY EVENTS 63,316 EDUCATION MATERIALS AND, 2,448 HOME SAFETY ITEMS WERE DISTRIBUTED. STATISTICS SHOW THAT WEARING A PROPERLY FITTED HELMET COULD

REDUCE THE RISK OF SEVERE BRAIN INJURIES BY 78%. GEORGIA LAW REQUIRES CHILDREN AGES 16 AND YOUNGER WEAR A HELMET WHILE RIDING A BICYCLE, ALTHOUGH SADLY THIS IS NOT ONLY DIFFICULT TO ENFORCE, IT IS NOT CONSIDERED A PRIORITY.

MORE CHILDREN AGES 5 TO 14 ARE SEEN IN EMERGENCY ROOMS FOR INJURIES RELATED TO BIKING THAN IN ANY OTHER SPORT. PREVENTION PROGRAMMING IN THIS FOCUS AREA CONSISTS OF A SERIES OF INTERACTIVE ACTIVITIES THAT TEACH CHILDREN THE PROPER USAGE OF APPROPRIATE HELMETS PER PARTICULAR SPORT, HELMET FITTING DEMONSTRATIONS AND IF AVAILABLE, HELMET DISTRIBUTIONS AT COMMUNITY WIDE EVENTS AND WITHIN CLASSROOMS. ACTIVITIES LIKE BIKE TO SCHOOL DAY; ARE AN IMPORTANT OPPORTUNITY FOR STUDENTS TO LEARN HOW TO REMAIN INJURY-FREE AS THEY BIKE TO AND FROM SCHOOL WHILE PROMOTING IT IS A SAFE AND FUN METHOD OF TRANSPORTATION. CHILDREN ARE ALSO TAUGHT WHY IT IS IMPORTANT FOR THEM TO WEAR THEIR HELMETS EVERY TIME THEY RIDE THEIR BIKES AND INSTRUCTED ON HOW TO ADJUST THEIR HELMET TO FIT PROPERLY.

IN 2017, GREATER AUGUSTA, FULTON, LOWNDES AND COBB COUNTY, HELD BIKE RODEOS THAT CREATED A SIMULATED DRIVING COURSE FOR THE PURPOSES OF TEACHING "RULES OF THE ROAD". GEORGIA COALITIONS HELD 177 BIKE SAFETY EVENTS, DISTRIBUTED 2,457 HELMETS AND SPENT 247 HOURS EDUCATING 40,772 CHILDREN AND THEIR FAMILIES ON WHEELED SPORTS SAFETY.
